CHOICES: Homeowners Rate Comparison Tool

The cost of homeowners insurance in Florida can vary significantly based on several factors in addition to geographic location:

- Type of construction
- Dwelling value
- Mitigation features
- Amount of deductibles

The CHOICES homeowners rate comparison tool provides sample average rates for a variety of companies writing insurance in each county, in addition to rates for Citizens Property Insurance Corporation. The rates quoted are for illustrative purposes and reflect information obtained from the most recent rate filings approved by the Office. These rate quotes are for the three pre-defined examples described below – premiums for your home will vary depending on individual circumstances. The Office recommends contacting an insurance agent or insurance company to obtain an official premium quote.

To start a CHOICES homeowners insurance rate comparison search:

STEP 1: SELECT AN EXAMPLE

1. [Select an Example](#)

- \$150,000 Value - Pre-2001 Construction w/ Wind Mitigation
- \$300,000 Value - New Construction

2. [Select by County/Company](#)

Select one of three pre-defined examples from the drop-down box for a home valued at \$150,000, built prior to 2001 with no mitigation discounts; a home valued at \$150,000, built prior to 2001 and with mitigation discounts; or, a home valued at \$300,000 built with new construction in 2005 and with limited mitigation discounts.

After making a selection, a summary description about the example is shown to include hurricane and non-hurricane deductible amounts, type of home construction and whether any previous insurance claims have been made on the home, etc.

STEP 2: SELECT BY COUNTY/COMPANY

There are two options available to choose from in this step. Select either “By County” or “By Company”.


- **By County:**
As the default selection, “By County” will automatically open when this step is accessed. To proceed, select a Florida county from the interactive map displayed.

- **By Company:**

Select the button “By Company” to show a drop-down box listing some of the insurance companies offering homeowners insurance coverage in Florida. Choose a company from the list to show this particular company’s sample average rates for all of Florida’s 67 counties.

STEP 3: VIEW RATES

Review the sample average rates “By County” or “By Company” for the pre-defined example chosen. For either, the list will display sample average homeowners rates.

For more information about any of the homeowner insurance companies on the list, click on an individual insurance company’s name to visit their website.

- **By County:**

A partial list of insurance companies offering homeowners insurance in Florida will be displayed along with each company’s sample average annual premium rates for the Florida county selected.

- **By Company:**

A list is displayed showing the sample average annual homeowners rates for the company selected in all of Florida’s 67 counties.
