On November 7, 2018, the NATIONAL COUNCIL ON COMPENSATION INSURANCE, INC. ("NCCI"), in response to an Order of the FLORIDA OFFICE OF INSURANCE REGULATION ("OFFICE") dated November 2, 2018, filed revised Workers' Compensation Rates and Rating Values ("Filing"), which modified its filing dated August 27, 2018. The Filing proposes a statewide Workers' Compensation Insurance rate level decrease of 13.8%, to be effective January 1, 2019, on new and renewal policies. NCCI's Filing contained all changes referenced in the OFFICE's Order dated November 2, 2018. Accordingly, it is therefore ORDERED:

The Filing requesting a statewide Workers' Compensation Insurance rate level decrease of 13.8% is hereby APPROVED.

Any party to these proceedings who may have a right to seek review of the Order pursuant to Section 120.68, Florida Statutes, and Rule 9.110, Fla.R.App.P., must institute such review by filing a petition or notice of appeal with the General Counsel, acting as the Agency Clerk, at 612

Larson Building, Tallahassee, Florida 32399-4206, and a copy of the same with the appropriate district court of appeal within 30 days of rendition of this Order.
